Purpose of Agreement

This agreement is entered into between Dixie Pugs of Tennessee (“Breeder”) and the undersigned Family for the purpose of securing placement on the Breeder’s puppy waiting list.

Preferences

Families may indicate a sex preference, which will be honored. Placement timing is dependent upon availability within upcoming litters.

Waiting List Deposit

A non-refundable waiting list deposit of \$200.00 is required to secure placement on the waiting list.

This deposit:

- Secures a position on the waitlist
- Will be applied toward the total purchase price of the puppy ultimately selected
- Does not expire
- Does not guarantee a puppy from a specific litter or timeframe

Hold Deposit Requirement

Once a puppy is available that matches the Family's preference, a hold deposit will be required to reserve that puppy.

The hold deposit:

- Is separate from the waitlist deposit
 - Will be outlined in a separate agreement
 - Is required to secure an individual puppy once offered
 - Is not due until the Breeder confirms availability

Estimated Wait Time

The current estimated wait time for a puppy is approximately 6–9 months. This timeframe is an estimate only and is not guaranteed.

The Family understands and agrees that:

- Placement timing is dependent on litter size, sex distribution, and overall availability
- Even in the event of a confirmed pregnancy, availability for any individual family is not guaranteed
- A confirmed pregnancy does not ensure that a puppy will be available within a shorter timeframe
- Unless the Family is applying for a currently available puppy, their placement timeline will generally remain within the originally estimated wait period

Breeding & Pregnancy Disclaimer

The Breeder plans all breedings carefully; however, the breeding process is subject to natural biological factors.

The Family acknowledges that:

- A breeding does not guarantee pregnancy
- Pregnancy is not confirmed until approximately 30 days post-ovulation
- There may be no visible signs of pregnancy prior to confirmation
- Heat cycles, conception, and litter outcomes can vary

These factors are outside the Breeder's control and may affect timing and availability.

Availability & Breeding Program Considerations

Placement on the waiting list does not guarantee a puppy from a specific litter.

The Breeder reserves the right to:

- Retain any puppy for evaluation or future breeding purposes
 - Make final placement decisions based on program needs, structure, temperament, and overall fit

Breeding & Show Rights

All puppies are placed as companions (pet homes), show prospects, or with full breeding rights on a case-by-case basis, at the sole discretion of the Breeder.

Breeding rights and show rights are not automatically granted and must be discussed and agreed upon in writing prior to placement.

The Family acknowledges and understands that:

- The desire to show a puppy must be communicated to the Breeder in advance, as it plays a significant role in placement decisions
- Not all puppies are suitable for the show ring, as show prospects must meet specific standards in structure, temperament, and overall development
- Show-quality and show-potential puppies will be evaluated and placed accordingly based on the Breeder's expertise and program goals
- In many cases, full registration rights are required for participation in conformation events, even if breeding is not planned

The Breeder reserves the right to determine:

- Which puppies, if any, are suitable for show or breeding homes
- Whether full registration will be granted

Spay/Neuter Requirement

All puppies placed as pets are sold with a mandatory spay/neuter agreement, as outlined in the final purchase contract.

Notification

Families will be notified within approximately 7–10 days after a litter is born if a puppy is available that matches their preferences.

By submitting a waiting list deposit, the Family acknowledges and agrees that:

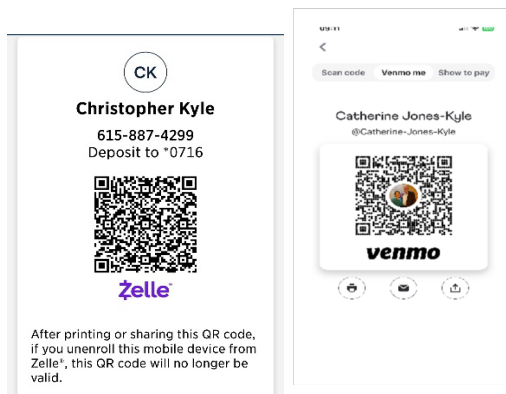
- The \$200 waiting list deposit is non-refundable

 - A breeding does not guarantee pregnancy or puppy availability
 - A confirmed pregnancy does not guarantee placement from that litter
 - The Breeder retains full discretion over all placement decisions
